>THE KAWEAH INDIAN NATION

>

>We the kaweah come from the Itza Indians who became known as the Anasazi of

>what is now the south west united states. Our history spans back over 3000

>years. The kaweah of today spreads from Canada to South America and number

>in the thousands.

>

> We were a dominant sea and river people from Mexico and Central

>America. We moved to what is now known as the south west United states of

>America. Around 150 years ago most of the tribe went underground. Now the

>great sea and river people, the ancient Anasazi are coming back into the

>light.

> The kaweah Indian nation is registered in the state of Nevada as

>state within a state. It is also registered as a corporation and a

>non-profit organization. The kaweah nation secretary of state main office

>is located in Wichita Kansas. We are not federally recognized as of yet.

>

> We believe that the people of Mexico at least most of them are

>Native American. There D.N.A. can prove this to be a fact. For hundreds of

>years we have been forced to forget our heritage our culture and give up

>our recognition. Some believe that Mexico is nothing more but a huge Indian

>reservation mixed up of hundreds or even thousands of different Native

>American tribes. We believe that those who chose to have there god given

>right to reclaim there history, culture and recognition of who they truly

>are should be able to do so.

>

> For thousands of years our people have migrated through out the

>Americas to hunt to trade in order to survive. We still do this today. But

>now we are called illegal aliens. How can one be native to a place and be

>called an illegal alien at the same time. It is not possible to be both.

>Our people did not cross these man made borders, they crossed us! History

>has proven that the natural order of life can not be contained, not by

>border patrol, military, walls or even ignorance. The natural immigration

>of natives is like the natural immigration of whales, birds or elephants;

>it is against the laws of nature and evolution to try to contain it. It

>would unbalance the world. Nature will find a way to overcome any attempt

>to unbalance it. We are not a second class race. We are not inferior. We

>have survived thousands of years of abuse, rape and murder by the same
 >people we welcomed onto our land. They were the real illegal aliens and
 >still we survive. Our hope for the future is that our people will have and
 >will take there god given right to reclaim there history there culture and
 >recognition, if they choose to do so. I hope that they will take some time
 >to look for there past and realize that they have a rich and powerful
 >history and are not weak little aliens.

 > As in every organization or movement there is corruption threatening
 >our cause and our people. People are being robbed, mislead and lied to by
 >some individuals. We had thought that by going through churches that these
 >things would be prevented but they were not. The majority of the churches
 >we work through are wonderful people who care about there members and there
 >community. Yet there are some who for reasons of misunderstandings,
 >impatience and even greed are hurting this movement and the people behind
 >it.

> I was assigned to stop this from happening, to police and monitor
 >the situation.

>I also educate the people and the pastures about what we are trying to do
 >and how we need to do it. We decided that every application would go
 >through my office in San Antonio as a way to screen the situation. Every
 >one who called in would have the ability to tell me if they have been taken
 >advantage of in any way. This is a very affective way of monitoring the
 >situation I learned of many problems and I have been able to correct them.
 >I have been working around the clock to stop the corruption and to educate
 >the people about our program but I was only assigned this position in
 >March. It takes time to do this. Regardless of how much time it takes I
 >intend to get it done.

> As our movement changes so does the understanding of our rights, one
 >day things are done like so and the next we have to change them. No one has
 >set an example for us to fallow we are learning together as we go forward.
 >Any one who has spoken to me or that I have spoken to know that we do not
 >adopt people. As far as I know it is not possible to adopt an adult. Nor do
 >we wish to. I also make it clear that the documents you receive hold no
 >federal, state, or any other government value. I make it clear that unless
 >this tribe gets federally recognized you can not get any social security
 >cards or work permits or any type of migrant or legal status. We are in the
 >process of preparing our case in order to submit it for our federal
 >recognition.

> Becoming a part of the Kaweah Indian Nation and receiving these
 >documents is our way of getting your legal testimony on paper saying, this
 >is who I am. I demand my recognition. I demand my blood rights. This serves
 >as proof for who ever needs to see it that you want back what is yours.

>

> We as a nation and a movement have been blamed for the actions of a

>few unscrupulous individuals. The accusations made toward the tribe and our
>movement are false and an insult to us and to the thousands of members
>fighting for our people. We will meet with the people making these
>accusations and explain to them and the media, in a way that they can
>understand. That if they would have contacted me or the office in Wichita
>and got an official explanation the way reputable organizations do it, they
>would have found out who we are and what we are doing. In stead they chose
>to try to get some kind of false glory for them selves by using the actions
>of a few people, who we are selves have been looking for not to mention
>putting our people, the same people they claim to represent at risk.

>
> I will contact these certain individuals and give them the opportunity to
>fix what they have done. I will ask them to the right thing. I will ask
>them to help us or to let us help them in regards to our people. If they
>refuse to clear up this situation we will be forced to press charges for
>slander.
